There had been some slowing in December and January related to front-range weather problems. Key focus for CSCUSA is Colorado Tourism office, I-70 congestion and support of their member ski areas.

Governor Ritter:

Governor Ritter's comments focused on the following areas: Climate Change, I-70 and overall transportation funding, affordable housing and work force issues and immigration. He also responded to questions on Forest Health, Water, and severance tax.
