



Issues at East Vail Trailheads

- Parking and Transportation
 - Trespass parking/use of private property
 - Illegal parking on frontage roads
 - Neighborhood impacts traffic/congestion
 - Safety conflicts between pedestrians and vehicles (especially along Booth Falls Rd.)
- Sanitation
 - Human waste
 - Garbage
 - Dog waste



Typical weekday at Gore/Deluge Trailhead

- Wilderness Character Degradation
 - Reduced opportunities for solitude
 - Trail crowding
 - Resource impacts to soil, water, wildlife, plants etc.
- Trail Infrastructure
 - Trail widening
 - Erosion
 - Tree carving
 - Campfire impacts

History

Complaints over the years increased during the mid 20teens

Due to

- Increased population
- proliferation of Social Media/Apps regarding trail promotion
- our own success of marketing summer business with the number one activity of visitors being hiking

Began meeting with the USFS in 2016 to address problems.


- 4 trailheads which access the wilderness.
- 3 of the 4 accesses are from residential roads with parking on Town of Vail land

- increased bus service from hourly to 30-minute service
- Forest Service created an alternate hiking trials brochure to encourage use of other trails verses the east Vail Trails

Hikers on Booth Creek Trail

- Comparison of the number of hikers at Booth: 2010 to 2019
- Includes 104 days from June 23 to Oct. 4
 - 2010: 9,082 hikers
 - 2019: 23,308 hikers



- Town formed a stakeholder group in 2019 to develop a plan to help work on solutions to alleviate the problems.
- Town and USFS brought in Volpe Center to assist with the development of potential Solutions
- Front Country Rangers and Vail Trail Hosts were implemented along with promotion/education.
- Intercept Survey was undertaken to provide insight of users

Trailhead Use Task Force Activities

- Identified and implemented summer/fall 2019 management activities (next slide)
- Examining immediate (next year), short/medium term (1-4 years), and long-term (5+ years) management strategies for each trailhead
 - Booth Creek has only immediate management strategies (subsequent slide)



Management Activities: Summer/Fall 2019

- Trail Host Volunteer Program
- Forest Service Front Country Rangers
- Hiker Survey (523 responses between August and September)
- <u>www.HikeVail.net</u> & outreach to other trail websites/apps
- Notices to concierge & front desk staff to avoid busy times on popular trails
- Portable toilets
- Signage improvements

- Promotions was the plan Covid exasperated the issues
- Transit was hardly used due to Covid transit restrictions
- Limited Hosts contacts due to Covid
- Limited Concierge educations
- Use increased by nearly 50 %

- Town closed the Booth Creek Trailhead parking(20 spaces) during the heavy summer use period but used the Vail Mountain School parking (80-100 spaces) to reduce neighborhood traffic
- Promotion of of Bus it to Hike it
- Heavy Vail Trail Host and Front Country Ranger presence
- Adopted a parking enforcement zone with increased fines of \$100 first violation with increasing penalty for repeat violators

- Town reopened the trailhead parking lot for drop off only to alleviate issues of nearby private properties
- Had the Vail Mountain School close their parking lot at all times
- Doubled down on Bus it to Hike it
- Implemented a stronger towing policy Added e-bike share station at the trailhead
- Use dropped by more than half





- Transit use before full closure was about 5% capture rate of hikers
- Eliminating parking options all together transit captured 35 -42 % of users
- Hotel shuttles were still encouraged to provide their services
- Biking and drop off were also encouraged
- Neighborhood walking access was still encouraged
