

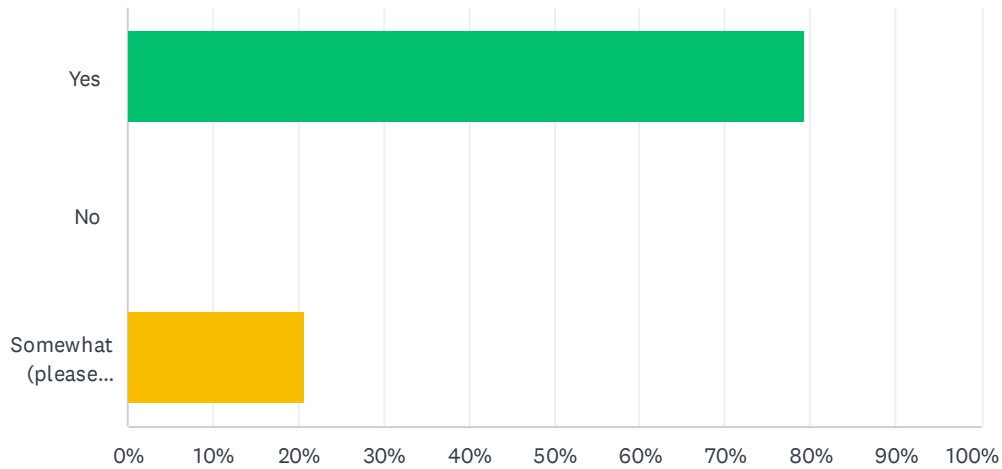

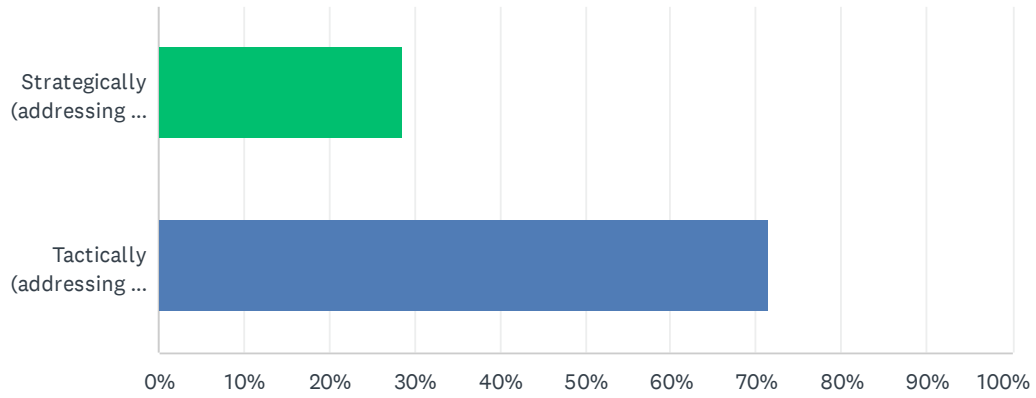

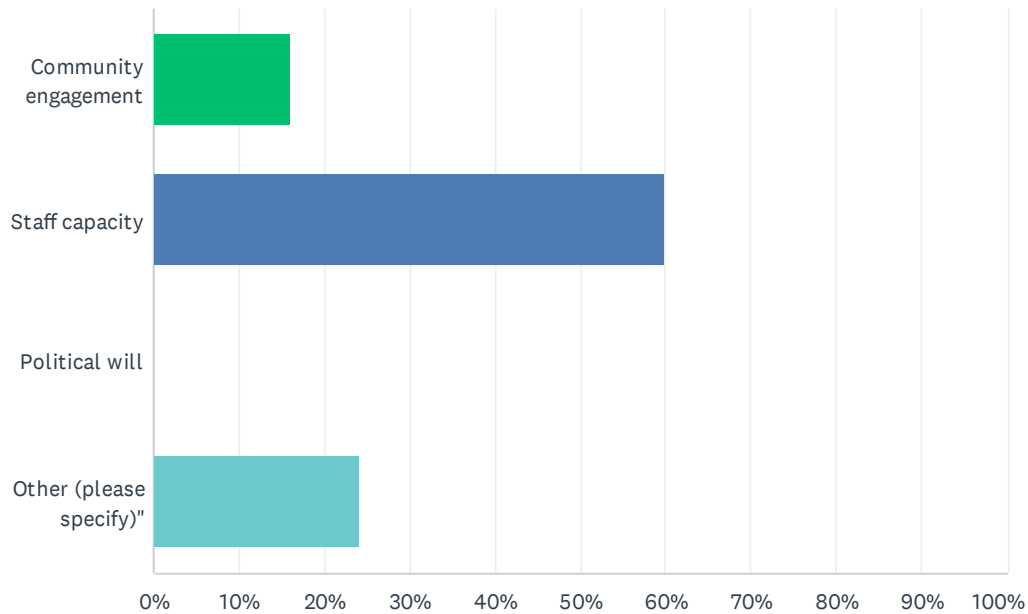

8	We take a more strategic overall approach that is made up of several underlying tactical approaches. Our model is very much a cooperative one in which we engage as many stakeholders as possible. A few examples of successful livability programs that come to mind are the work force development program, which is mainly a cooperative internship program between the Salida School District and CMC but also involves the Municipalities, the County, and the Economic Development Corporation, that provides High School Seniors with real world work experiences. Another notable example is the Forest Health Council which is a cooperative land health initiative between Chaffee County, the USFS, BLM, CPW, Colorado State Forest Service, Lake County, National Forest Foundation, Utilities, Fire Protection Districts, and private landowners hosted under the Envision Chaffee County umbrella. Through our intergovernmental Housing Authority, we regularly collaborate between the county and the municipalities to ensure that we are coordinated in grants-seeking and intentional development decisions that consider the regional needs and priority growth zones. The County within its Land Use Code updates and Sustainable Development Plan creation also convenes diverse stakeholder groups that work to develop and align land use and sustainable development policies to best balance protections of community character and natural resources while promoting smart growth, supporting local economic diversification, and strengthening our social services. Overall, we have initiative's working in almost all of the listed areas of livability and are actively working to integrate them in an overarching structure that guides our decision-making moving forward.	12/18/2023 12:53 PM

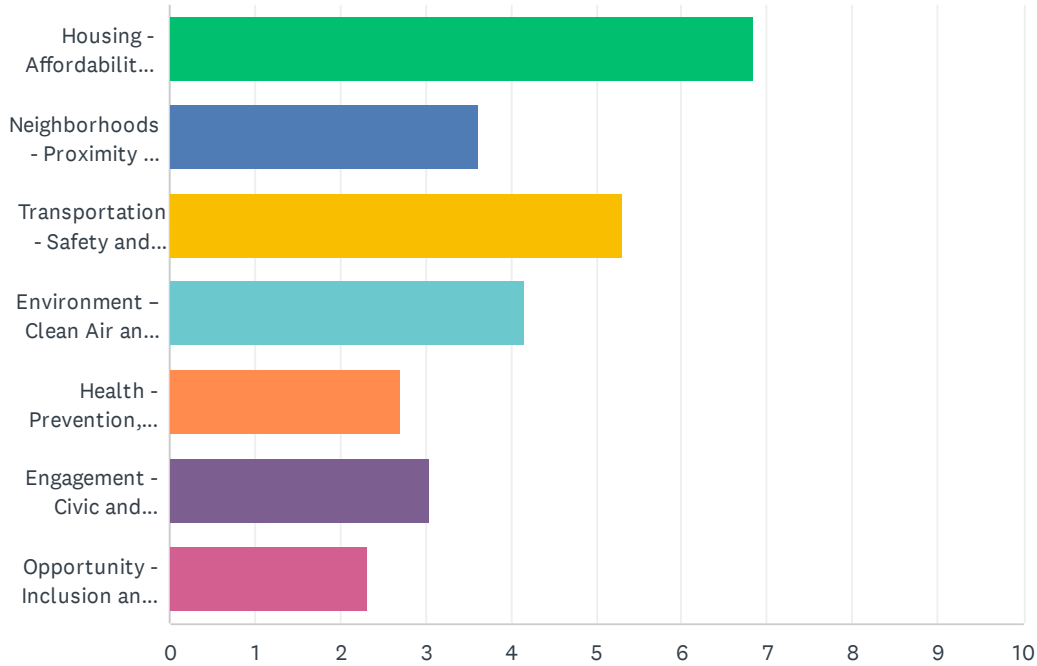

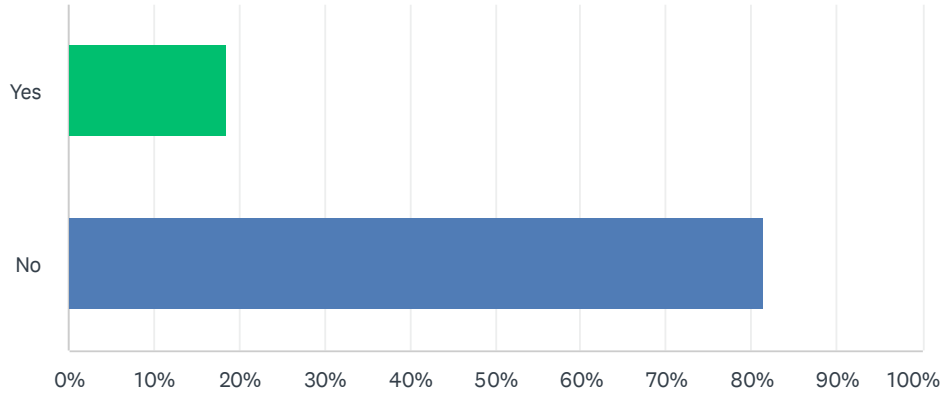
